1. Name of Work

- 1.1. Name of work is **“Supply of items to SPORTS, Lakshadweep Tourism”** UT of Lakshadweep Administration”.

2. Definitions

- 2.1. Purchaser means SPORTS, Lakshadweep Tourism, UT of Lakshadweep Administration, Kavaratti.
- 2.2. Bidder means any bidder participating in this tender.
- 2.3. Successful Bidder means bidder selected by the purchaser.
- 2.4. Supplier means successful bidder to who confirmed Letter of award has been issued by the purchaser.

3. Scope of Work

- 3.1. The Bidder shall supply the items specified in Appendix-A for the purchaser subject to the terms & conditions of this tender document.
- 3.2. Bidder shall bound to supply the goods at any point as per confirmed Letter of award during the validity period of contract.

4. Availability of Tender documents

- 4.1. Tender documents shall be available for downloading in the official website of SPORTS Lakshadweep Tourism

- 5.2. If the bid opening date given above falls to be a holiday, the opening of bid shall be held on the next working day.
- 5.3. Purchaser reserves right to alter the date of opening of Bid without assigning any reason and any such alteration shall be updated in the website.

6. Pre-Qualification Criteria for Bidder

- 6.1. Bidder shall be an individual/ organization/ company or their Authorized Distributors/ Agents.
- 6.2. GST Registration: Bidder shall be registered under Goods & Service tax Network and shall have a valid GSTN Number. Copy of valid GST Registration Certificate shall be submitted along with the bid.
- 6.3. Not to be a blacklisted/ debarred party: Bidder shall not be either blacklisted or debarred by Central Government or any of the State/ UT Government. A self declaration to this effect shall be submitted along with Bid.
- 6.4. Adhere with tender conditions: Bidder shall adhere with all the terms & conditions of this Tender document. If any deviation is suggested it shall be spelt out clearly. A self declaration to this effect with deviations, if any, shall be submitted along with Bid.
- 6.5. Income Tax Registration: Bidder shall be registered with income tax department and shall have a valid PAN/TIN number. Copy of valid PAN/Tin card shall be submitted along with bid

9 Bid System

- 9.1. The bid is invited in two (2) cover Bid System consisting of;

- 9.2. Format for submission of Bid is attached as Annexure- A & B. The Bid as per Format Annexure- A & B shall be properly filled and submitted separately in sealed cover along with the Bid.
- 9.3. The bids is to submitted in two cavers detailed below;

9.3.3 Both covers should be sealed separately and the name of the agency, address and telephone number should be printed on each cover. 10.2. EMD as per the schedule shall be submitted by means of remittance to the Bank Account of the purchaser. Copy of Remittance Slip shall be attached with the Bid.

10.3. EMD of unsuccessful bidder shall be released/ refunded after finalization of the tender and awarding of work to the successful bidder.

10.4. EMD of successful bidder shall be released/ refunded only after receipt of Performance Guarantee/ Security Deposit as per this tender document.



- 10.5. EMD shall not bear any interest under any circumstances and bidder shall not have any right to claim interest on EMD.
- 10.6. EMD of successful bidder, who fails to submit Performance Guarantee / Security Deposit, shall be forfeited.
- 10.7. Purchaser reserves all rights to realize any amount from the EMD as Liquidated Damages/ Penalty to be charged from the bidder as per this tender document.

11. Opening of Bids

- 11.1. Bids shall be opened by a Tender Opening Committee duly constituted by the Purchaser.
- 11.2. Bids shall be opened in the Office of the Deputy General Manager, SPORTS HQ Office, Lakshadweep Tourism, Kavaratti or any other place authorized by the Managing Director SPORTS. Date & time will be announced later.
- 11.3. Bids shall be opened in the presence of attending bidders or their authorized representatives, in person or via video conference.

12. Evaluation of Bid

- 12.1. There shall be a Tender Evaluation Committee (TEC) constituted by Purchaser for evaluation of the Bids.
- 12.2. Tender Evaluation Committee will evaluate bids and item-wise L1 shall be determined and recommended.

13. Letter of Award (LOA)

- 13.1. After finalization of the tender, Purchaser will issue Letter of Award (LOA) to the successful bidders by registered post and email. A copy of the same will also be published in the official website of SPORTS Lakshadweep Tourism.

14. Performance Guarantee/ Security Deposit (PG/ SD)

- 14.1. Successful bidder shall submit Performance Guarantee/ Security Deposit separately for cost of equipment including warranty period.
- 14.2. PG/ SD for cost of the equipment including warranty period shall be equal to 10% of cost of equipment stipulated in the Letter of Award (LOA). PG/ SD for cost of the equipment shall be submitted within 7 days from date of issue of Letter of Award (LOA). PG/ SD for cost of the equipment including warranty period shall be submitted separately for each Letter of Award.



- 14.3. PG/SD shall be submitted by means of Bank Guarantee/bank transfer from any nationalized bank.
- 14.4. PG/SD of the bidder, who fails to comply with the conditions of Tender document & Letter of Award shall be forfeited.
- 14.5. Purchaser reserves all rights to realize any amount from the PG/SD as Liquidated Damage/ Penalty to be charged from the bidder as per this tender document.

15. Delivery

- 15.1. Place of Delivery: Goods intended in the confirmed Letter of Award shall be delivered by the Supplier to the SPORTS (Lakshadweep Tourism) Kochi Unit, within 20 days from the date of Letter of Award. The place of delivery mentioned in the tender document is tentative and the successful bidder will be responsible to supply the indented items at the point of supply within the time period specified in the confirmed Letter of Award.
- 15.2. All costs of transportation, incidental chargers and loading & unloading charges up to the place of delivery shall be borne by the Supplier.
- 15.3. Supplier shall pack the goods in strong cases sufficiently stuffed with packing materials to avoid any breakage/ damage/ loss in transit till the reaching point of delivery. The safety of the goods up to the supply point shall be the responsibility of the Supplier and Purchaser shall not be responsible for any breakage/ damage/ loss/ theft of the goods during its storage/ transit due to any reasons, natural or otherwise.
- 15.4. Time Period: Goods intended in the letter of award shall be supplied within 20 days from the issue of confirmed supply order. Delayed supply, except under force majeure conditions, shall attract the Liquidated Damages clause of this tender document. The time period of supply mentioned here is tentative and can vary as per the decision of purchaser. The bidder shall be bound to supply the goods within the time period as per confirmed supply order.
- 15.5. Undue Delay: If the delay in supply, except under force majeure conditions, exceeds three times the allowed supply period, Purchaser reserves the right to reject such undue delayed goods and also to cancel that letter of award and/or cancel the supply as a whole.
- 15.6. Supplier shall be responsible to clear the rejected goods from the premises of delivery at their own cost within 10 days of issue of rejection notice. Delay/ Non-clearing the rejected goods shall attract the Liquidated Damages as same as delay for delivery & installation clause of this tender document.



16. Quality of goods

- 16.1. Goods supplied shall meet all the standard norms of quality for those goods prescribed by the concerned Government authority and/or of the same specification mentioned in the tender document.
- 16.2. Purchaser reserves all rights to verify the quality of goods supplied by Supplier through any Government approved/ identified agency.
- 16.3. If it happens to be came to the notice at any point of time that the goods supplied are of substandard quality or not as per required specification a notice will be issued to the Supplier to provide documentary evidence to prove the quality/ specification of goods supplied and it should be proved by the Supplier within 15 days from the date of issue of such notice. All costs for quality proven on the basis of such notice shall be borne by the Supplier.
- 16.4. If the Supplier fails to prove the quality within the stipulated timeframe, payment for such substandard goods shall not be released.

17. Warranty

- 17.1. The equipment shall be under warranty for a period mentioned by the manufacturer from the date of supply; minimum warranty period is 6 months.
- 17.2. During the period of Warranty supplier shall attend Unforeseen/ Breakdown Maintenance as and when required by the customer. The supplier shall attend the call for Unforeseen/ Breakdown Maintenance by the purchaser in a time bound manner.

18. Force Majeure

- 18.1. Delay from the side of Supplier for execution of any of the conditions of this tender document under force majeure conditions like natural calamities or any other similar situations, delay in getting entry permit for service engineer, delay in getting space allotment for transportation of goods, time taken to carryout modification/ rectification suggested for manufacturer compliant, etc. shall be condoned subject to proper justification furnished by the Supplier in due course of time. However, the decision of Purchaser in this respect shall be final.

19. Penalty/ Liquidated Damages

- 19.1. If the Supplier fails to supply the goods at point of supply within the stipulated time frame, LD @ 0.5% of cost of equipment including warranty cost per week or part thereof subject to a maximum of 10% of the cost of equipment including warranty cost for the delayed



period will be charged from the Supplier. The payment towards the cost of the equipment shall be released only after deducting the LD amount thus calculated.

- 19.2. Liquidated Damage/ Penalty for each item like delay in delivery, delay in clearing unaccepted goods etc shall be charged separately and are mutually independent.

20. Payment Terms

- 20.1. Supplier shall submit the invoice for the goods supplied at the designated supply points along with certificate issued by the officer appointed for the purpose by purchaser to the effect that supply has been done successfully and specification is matching with supply order.
- 20.2. 100% payment towards the cost of equipment including supply shall be released only after getting the certificate from the authorized officer to the effect that equipment has been successfully delivered and after verifying the correctness of PG/ SD towards cost of equipment including warranty period submitted by the Supplier.
- 20.3. Payment shall be released after deducting/ adjusting the Liquidated Damages/ Penalty, TDS and any other dues due to the Government.
- 20.4. Advance or part payment shall not be made under any circumstances and enhancement of rate shall not be entertained during the validity period of Letter of Award.

21. TDS & Other Taxes

- 21.1. Income Tax at the prevailing rate as per rules shall be deducted from the payment to the Supplier, for which TDS Certificate as per prevailing rules shall be issued.
- 21.2. Any change in Tax rate shall be made applicable as per rules while releasing the payment to the bidder. If the change is an increase in Tax rate, it is the bidder's responsibility of the bidder to prove this by producing documentary evidence to showing tax rate for that particular item at the time of tendering and at the time of rising of invoice/ releasing of payment.

22. Arbitration

- 22.1. The tender, supply order and contract agreement to be executed shall be governed by Indian Laws.
- 22.2. In the event of any dispute or difference between the parties hitherto, such dispute or difference shall be resolved amicably by mutual consultation or through the good office of empowered agencies of the



Government. If such resolution is not possible, then, the unresolved dispute or difference shall be referred to arbitration of an arbitrator to be appointed by the Administrator, UT of Lakshadweep. The award of the arbitrator shall be binding upon the parties to the dispute. Provided however any party aggrieved by such award may make a further reference for setting aside or revision of the award to appropriate authority in Kavaratti, UT of Lakshadweep whose decision shall bind finally and conclusively. The arbitration shall be carried out in English language.

23. Jurisdiction

- 23.1. The dispute, if any, between the parties shall be settled at District & Sessions Court, Kavaratti, UT of Lakshadweep and contract shall be interpreted under Indian laws.

24. Termination Letter of Award

- 24.1. Violation of any of the conditions of tender document or letter of award shall entail cancellation of tender/ supply and initiate legal action against the bidder including the blacklisting the firm.
- 24.2. Purchaser reserves all rights to cancel the tender/ contract in full or in part at any time even without assigning any specific reason.
